Recovery was a prevalent theme in northern Montana in 2022, and the team at Bear Paw Development was here to move our communities along. As we watched the pandemic and all the economic uncertainties associated with it wind down, we were able to step up and serve our Economic Development District in unprecedented ways. All of Montana breathed a sigh of relief this year as we began to resume our normal lives, and we were pleased to assist our area to grow and thrive.

Perhaps the most notable work at Bear Paw Development in 2022 was assisting our local governments with the sizable American Rescue Plan Act (ARPA) funds allocated to implement upgrades and replacements of aging infrastructure. Overall, Bear Paw's Community Development Department managed over \$17 million of ARPA funds for our District, with projects including water, wastewater and levee upgrades and replacements,

among others. These funds have been combined with leveraged dollars from other sources to significantly fund multiple projects that will have a lasting impact in our region for decades to come.

Collectively, our work resulted in managing over \$21 million in projects to help our communities recover from the COVID-19 pandemic. There were also 45 jobs created or retained through our economic development work as we help northern Montana return to its prepandemic state.

Bear Paw Development also embarked on a personal transition as well in 2022. After 25 years in the Ryan Building, our staff moved into a new office space in downtown Havre. These offices not only allow our staff more room to conduct our important work, but also allows space for growth as needed for our organization. Bear Paw takes great pride in the new location, and looks forward to years to come in this location.

We appreciate everyone's support in what was an enormously successful year for Bear Paw Development and our communities, and we are excited to carry it through to 2023!

Eager to move forward, Mischelle contacted Joe LaPlante, Havre's Small Business Development Center Director, for assistance with her business plan and financial projections. Once completed, she secured funding from Bear Paw Development's Revolving Loan Fund for construction and equipment. Prairie Paws Resort opened its doors for business in September and currently has 14 large kennels and 13 small kennels as well as a washing and grooming area. 

Geraldine Water Improvements Project

GERALDINE

Beginning in the summer of 2023, the Town of Geraldine will undertake Phase One of a muchneeded upgrade to their springs water system. Geraldine's water system was originally constructed in 1935 of wood stave pipe, and was upgraded in the 1950s with the installation of several blocks of asphalt cement (AC) piping, ranging in size from three to eight inches in diameter. The 1950s pipe is well past its useful life and is also undersized for the community it serves.

Phase One of Geraldine's project will include the replacement of 6,800 ft of water main, upgrading water service connections and installing new fire hydrants. This upgrade is projected to cost about \$2.7 million. Chouteau County partnered with Geraldine to contribute a large sum of their American Rescue Plan Act (ARPA) funds to the town's project. Bear Paw Development assisted Geraldine and the county in leveraging all ARPA funds, which included successfully applying for a \$2 million ARPA Competitive grant. These funding sources allowed Geraldine to move forward with a 100% grant funded Phase 1 Water System Improvements Project, which is of special significance as water projects often require local governments to take out loans to complete these projects. The new water system is being designed by Great West Engineering and construction will begin in mid-2023. "When industries change and communities develop, Montana's towns and cities are often left to foot the bill on cleanup efforts. My bipartisan infrastructure law will help to change that by reinvesting in the communities that have been most affected by leftover contamination and pollution. By working across the aisle with five Republicans and four other Democrats, we were able to secure critical funding to repurpose old or abandoned properties in the Treasure State and create good paying Montana jobs in the process."

Brownfields RLF Award

Bear Paw Development was awarded \$2.15 million in supplemental funding for their Brownfields Revolving Loan Fund (RLF) in 2022. Bear Paw has had a Brownfields RLF since 2011 with \$1.5 million secured over those 11 years to assist cleanup efforts with petroleum contamination and hazardous building material abatement in its five-county region. This significant award will allow Bear Paw to continue providing subgrants and loans to more communities and properties, converting under and unused contaminated sites into businesses and attractions.


Over the years, Bear Paw's RLF program has completed four loans and eight subgrants for projects including the Boys and Girls Club of the Hi-Line in Havre, Malta Opportunities in Malta, Kaste's Building in Big Sandy, and the Chester Vets Club in Chester.

Rudyard Senior Center

RUDYARD

Bear Paw Development secured a \$30,000 Community Development Block Grant for the completion of a preliminary Architecture Report on the Rudyard Senior Center, with a \$10,000 match contribution from the Rudyard Community Commercial Club. The senior center provides services and meals to the growing aging population of western Hill and Blaine counties, and the facility has begun to fall into disrepair. The building is used not only to provide services to seniors, but also for numerous community events. Given its importance to Rudyard and the surrounding communities, there is significant interest in finding a way to repair the building and avoid blight on the main street.

Nelson Architects was selected for the project and has provided a PAR which can now be used to leverage the significant funding raised by the communities along with grants to bring new life into the facility.

Montana Greenhouse Project 365

MALTA

In the fall of 2022, Christian Simpson, Owner of Montana Greenhouse Project 365 received \$49,999 in USDA Value Added Producer Grant funding to expand his greenhouse hoping to be able to offer more locally grown produce to Malta and the surrounding area. Originally Christian had not considered running a full-scale greenhouse business, but after being contacted by several local schools interested in purchasing locally raised products for their school lunch programs, he decided that he would expand his operation to assist with meeting this demand.

With the USDA grant funding and assistance from Bear Paw Development's Food and Agriculture Development Center, the Montana Greenhouse Project 365 will be able to provide packaging for its produce, expand into other school districts, and offer health and nutrition classes to participating schools each month that further promote consumption of locally grown products. These classes will teach the community how to grow their own vegetables, how to make a meal plan, vegetable canning, and even foraging for wild food.

Montana Greenhouse Project 365 is located at the Sleeping Buffalo Resort 20 miles east of Malta.
